The Fund aims to deliver a high and stable income yield, together with the potential for capital appreciation, by investing in a diversified portfolio of UK commercial property.

Fund benchmark

To outperform the IPD Universe benchmark.

Quarterly highlights

- **New lettings** - Two new lettings and one lease renewal completed this quarter, creating additional contracted rental income for the Portfolio of approximately £210k p.a.
- **Void reduced** - Portfolio void, as a percentage of ERV, reduced to 23% during the quarter.
- **Outperformed IPD** - Positive capital growth return due to asset management initiatives resulted in the Portfolio outperforming its IPD benchmark during the quarter.
- **Strategic sales achieved** - Following the three successful sales achieved in 2012, a further two strategic disposals have been completed in the year to date.
- **Bank borrowings reduced** - Outstanding debt balance reduced by a further £1.0m during the quarter.

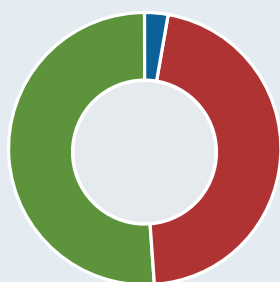

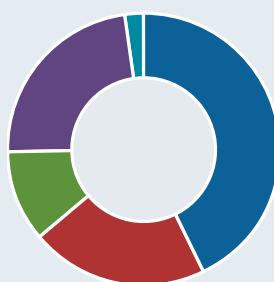
Portfolio sector split by value as at 31.03.2013
